directed to inform you that your proposal has been found viable
prima facie based on the details furnished in your application
form and in subsequent presentation before a duly constituted
EC-subcommittee.

To facilitate further processing of the proposal you are now
requested to furnish the following to the SOUTHERN REGIONAL
OFFICE, AICTE, 26, HADDOWS ROAD, CHENNAI 600 006 :

1. Registered sale deed "in original" showing absolute
ownership and title of the proposed land in the name of the
Trust/Society. (Please note that lease deed is not
acceptable, unless it is a Government Lease)" It is the
responsibility of the Trust/Society to ensure that the land
is in the name of the Trust/Society and not in any
individual's name.

In case it is planned to establish the proposed institution in the campus of an existing institution, the area as required for the proposed Institution (Annexure I) should be exclusively earmarked for the Institution. The area must be earmarked by an irrevocable resolution of the Trust/Society recorded on a non-judicial stamp paper duly notarised.

2. The land use certificate from the concerned Competent Authority;
 - (i) Municipal Corporation in the case of Metro-Cities, State capitals and District Headquarters
 - (ii) Panchayat or other Competent Authority in the case of areas not covered in the Municipal Limits of Metro Cities, State Capitals and District Headquarters.
3. A Cumulative Fixed Deposit only in a Nationalized/Scheduled Bank in the joint name of Trust/Society and the concerned Regional officer for a period of 10 years for the amount as applicable to the category of the institution indicated in the annexure to this letter(Annexure I). FDR should be created by duly obtaining the signature of the concerned Regional Officer on the FDR application form(Please refer the Guidelines at Annexure II). FDR should be opened only in the Branch on whose application form signature of the concerned Regional Officer was obtained.
4. A non-refundable processing fee of Rs. 50,000/- (Rupees Fifty thousand only) in the form of a crossed(account payee) demand draft (Payable at the city where the Regional Office is situated) in favour of the Regional Officer concerned. Only after the receipt of the processing fee, the Regional Office will start consideration of your proposal and will take up further examination of the proposal and entertain any further correspondence in this regard.

You are to fulfill all the requirements indicated at 1,2,3, and 4 at the earliest but not later than March 31, 1999, the cut-off date.

It shall be the responsibility of the Trust/Society to submit all documents strictly in accordance with the requirements of this Letter of Viability before the cut-off date. Failure to do so will result in ipso facto cancellation of this Letter of Viability. Please note that the Council shall not entertain any request for relaxation in the cut-off date due to any reason.

Kindly refer to the Council's earlier letter/ Notice(s) advising you to shift to the permanent site on or before 30th June, 2003 or in exceptional cases up to the current academic year.

However, keeping in view the interests of the students, the Council has taken a conscious decision to grant the institutions yet another opportunity for shifting to permanent site before the commencement of the next academic session i.e. 2004-05. This is the last and final chance given to the institutions and no further appeal in the matter will be entertained. A monitoring visit shall be conducted during the academic year 2003-2004 on the temporary site.

Please note that institutions failing to comply with this direction will be liable for punitive action.

In the light of the above decision of the Council and as per the laid down procedure, Guidelines, Norms & Standards of AICTE, I am directed to state that AICTE hereby grants of approval of extension J.S.N. 

As you are aware, All India Council for Technical Education has been mandated under the AICTE Act, 1987 to ensure **maintenance of norms and standards** with regard to technical education in the country. In exercise of this mandate, the Council insists on fulfillment of the minimum requirements prescribed for imparting technical education by the institution so that **quality of courses** is not compromised and stakeholders are satisfied. The Council also undertakes an **annual inspection** of the institutions and conveys deficiencies to them for **rectification**.

It has been observed however that notwithstanding the Council's **repeated advice** to comply with minimum norms and standards, many institutions continue to be **complacent** about taking steps to remedy the deficiencies.

Such institutions suffer from **critical deficiencies** of faculty in proper cadre ratio, qualification, experience and other requirements. Feed back of students with regard to quality of education imparted by such institutions has evoked grave concern. The Expert Committees, following **holistic appraisal** during inspections, have also pointed out severe shortcomings.

The institution has been found to be suffering from several deficiencies, which are listed in **Annexure-A** for your perusal. Shortage of faculty is of gravest concern.

The deficiencies in respect of faculty (including proper cadre ratio & qualification etc.) could have rendered your institution liable for punitive action including being placed in no admission/ reduced intake category. However the Council has decided to take a lenient view and give you yet another **last opportunity** to rectify the deficiencies particularly with regard to faculty shortage, proper cadre ratio & requisite qualification. Course-wise approved intake in respect of **J.S.N. The State Government/ UT/ Directorate of Technical Education/ Directorate of Medical Education shall ensure that 10% of reservation for Economically Weaker Section (EWS) as per the reservation policy for admission, operational from the Academic year 2019-20 is implemented without affecting the reservation percentages of SC/ ST/ OBC(NCL) / General. However, this would not be applicable in the case of Minority Institutions referred to the Clause (1) of Article 30 of Constitution of India. Such Institution shall be permitted to increase in annual permitted strength over a maximum period of two years.
2. The Institution offering courses earlier in the Regular Shift, First Shift, Second Shift/Part Time are now amalgamated as total intake and shall have to fulfil all facilities such as Infrastructure, Faculty and other requirements as per the norms specified in the Approval Process Handbook 2023-24 for the Total Approved Intake. Further, the Institutions Deemed to be Universities/ Institutions having Accreditation/ Autonomy status shall have to maintain the Faculty: Student ratio as specified in the Approval Process Handbook.
3. Strict compliance of Anti-Ragging Regulation, Establishment of Committee for SC/ ST, Establishment of Internal Committee (IC), Establishment of Online Grievance Redressal Mechanism, Barrier Free Built Environment for disabled and elderly persons, Fire and Safety Certificate should be maintained as per the provisions made in Approval Process Handbook and AICTE Regulation notified from time to time.
4. In case of any differences in content in this Computer generated Extension of Approval Letter, the content/information as approved by the Executive Council / General Council as available on the record of AICTE shall be final and binding.
5. As per the AICTE Notification dated 29.01.2014 and amended thereto, it shall be mandatory for each Technical Education Institution, University Department and Institution Deemed to be University imparting Technical Education to get accreditation (NBA) for at least 60% of the eligible courses in the next ONE (1) Years' time, otherwise EoA for the subsequent Academic Year (A.Y. 2024-25) shall not be issued by the Council.
6. Deemed to be University: Institutions Deemed to be Universities (Running Technical Education Programmes), it is mandatory to have AICTE approval from the Academic Year 2018-19 in compliance of the Hon'ble Supreme Court Order dated 03-11-2017 passed in CA No.17869- 17870 /2017.
